- 1. Meeting Called to Order by Austin at 5:04 PM.
- 2. Present Austin, Klein, Schulz, Mundt, Thome
- 3. Secretary's Report Motion to approve June 30, 2021 Meeting Minutes by Thome, second by Mundt, approve by all. Motion to approve August 12, 2021 Meeting Minutes by Klein, second by Mundt, approved by all.
- 4. Treasurer's Report: \$18,448.93 in Savings. We are on track per the budget. Short discussion that the taxes may change if the town changes the Mil rate, but overall, we should be okay with our budget. Lottery credit may be taken out of the report. Motion to accept the Report by Schulz, second by Austin, approved by all.
- 5. Fish Stocking Discussion: Schulz had communication with Zach from DNR. Reports from fisherman were similar. Any Walleye caught were large, but very few overall. Zach felt lake is suitable to sustain natural reproduction for panfish therefore stocking Crappie or any type of panfish was not suggested. Opinion was to continue stocking Walleye maybe altering loading sites as the landing area is heavily fished and predators are plenty. DNR will conduct a fish survey in 2022. Board authorized Schulz to proceed getting the stocking done for the fall of 2021.
- 6. LMP Update / Outlet Vegetation Issue: Whitewater and the DNR toured the lake with Austin. Conclusion was that shoreline property owners in affected areas can still get their boats in and out to open water. Any dredging or harvesting does not qualify for grant money and is very expensive. Dredging could be up to a million of dollars. Suggestion was to have owners do their own harvesting which is allowed up to a 30 ft. wide path out from shore to open water.
- 7. Annual AIS Survey Results: Results were not received in time for review before the meeting, but nothing was expected to be abnormal. Yellow Iris plants were observed, and property owners are advised to remove them.
- 8. Dale Jalinski Recognition Update: Dale will be in attendance at the annual meeting to accept the plaque. Mundt has the plaque completed and ready. Austin will read a short message regarding Dale and present the plaque.
- 9. County Report: Robert Thome gave a recap the County Report which was sent to all Commissioners and is available to the public.
- 10. 2022 Budget Proposal: Budget was reviewed briefly as it was the same budget approved at the August 12<sup>th</sup> meeting. Motion to carry it to the Annual Meeting made by Schulz, second by Mundt, approved by all.
- 11. Commissioner Klein's Term: Klein's term expires in September 2021. Klein stated he will rerun if appointed. Austin will fill out a ballot for the Annual Meeting and the vote will take place.
- 12. 2021 Annual Mtg Discussion: Discussion on where to hold the Annual Meeting. Thome suggested the Pavilion as the first choice due to the uncertainty of feelings due to COVID. Second choice would be the Town Hall if bad weather. All agreed.
